



T-SHIRT DESIGN CONTEST TERMS AND CONDITIONS

FEBRUARY 19-22, 2023

1. How to Enter:

• NO PURCHASE NECESSARY TO ENTER OR WIN.

- You can enter to Design our next T-Shirt Contest by submitting a T-shirt design at <https://www.viticusgroup.org/t-shirt-contest> Designs must fit within an 8"x8" space. Entries must be submitted in .jpg, .png, .pdf, .ai, or .psd format, and be no larger than 10 MB. You must complete all required information on the Entry website to be eligible to enter to win a prize. Incomplete, illegible, duplicate, corrupted or untimely Entries are void and will be disqualified. Entries must be submitted by the individual entrant. All Entries become the property of WVC dba Viticus Group "Viticus Group" when submitted and will not be returned to entrant. The Contest Period begins on July 14, 2022 at 12:00 A.M. Pacific Standard Time and ends on August 22, 2022 at 11:59 P.M. Pacific Standard Time.

2. Sponsored by:

3. Eligibility:

- The Contest is open to all veterinary professionals including veterinarians, veterinary technicians, veterinary assistants, veterinary nurses, and practice managers.

4. Duration.

- Entries for the Contest will be accepted only during the Contest Period.

5. Limitation on the Number of Entries:

- Limit one entry per person. Additional entries will be disqualified, and Viticus Group reserves the right to disqualify any person that submits multiple entries. Multiple, automated, bulk entries, or entries submitted by third parties will be disqualified, and will void all entries by that Entrant.

6. Prize(s):

- Five (5) total prizes will be awarded.
- Each grand prize winner will receive a complimentary registration to the 95th WVC Annual Conference, and a T-shirt with their Entry on it (total approximate value: \$900). In addition, each winner shall have their Entry used on an upcoming series of t-shirts produced by Viticus Group.
- Two (2) runner ups will receive one \$50 gift card and the opportunity for their Entry to be used on an upcoming series of t-shirts produced by Viticus Group.
- Viticus Group has absolute discretion to choose the prizes and no requests for substitution or replacement will be honored. All prizes are nontransferable and must be accepted as awarded.

7. Winner Selection and Notification:

- Winners will be selected by a panel of judges chosen by Viticus Group using subjective criteria from all eligible entries received. All decisions made by Viticus Group in relation to the Contest are final and binding. All entries must be submitted by Monday, August 22, 2022, at 11:59 p.m. Pacific Standard Time. The judges shall make their selection on or before August 24, 2022. The winners shall be notified by email within 7 days of the contest conclusion. The sole obligation of Viticus Group is to send an email to the address provided in the entry form. The winners will have 10 days from the sending date of the winner notification email to respond. If the prize is not claimed within the 10 day time limit, an alternate prize winner will be selected by the same panel of judges from all eligible entries received. The original prize winner will forfeit all rights and have no further rights to any prize nor any claims against Viticus Group based on the forfeiture of their winnings. Return of prize or winner notification as undeliverable, failure to respond to notification, failure to reach the winner and/or failure to provide required proof of eligibility and release(s) in a timely manner may result in disqualification and selection of an alternate winner via a random drawing from all eligible entries received.

8. Error Correction:

- Viticus Group reserves the right to correct or change any and all printing, typographical or mechanical errors. - Where permitted by law, winners grant to Viticus Group (which grant will be confirmed in writing on request), their subsidiaries, affiliates and those acting pursuant to their authority, the right to print, publish, broadcast and use, worldwide in any media now known or hereafter developed, including but not limited to the world wide web, at any time or times, the winner's name, portrait, picture, voice, likeness, city and state of residence and biographical information for advertising and promotional purposes without additional consideration. Except where prohibited by law, winners will be required to sign an Affidavit of Eligibility and Release or forfeit the prize. Failure to comply, or return any required releases and related documentation, may result in forfeiture of the prize.

11. License.

- By entering in the Contest and submitting an Entry, Entrant grants to Viticus Group a royalty-free, perpetual, nonexclusive, worldwide license to copy, distribute, modify, create derivative works based on, publicly display, and otherwise use the Entry for any reason whatsoever, including but not limited to placing the Entry on t-shirts for public distribution. - Winner agrees to provide such financial information (which may include the winner's social security number) to Viticus Group as is necessary for Viticus Group to complete all necessary tax forms in order to comply with federal, provincial, state and local tax requirements.
